Professional biography

On September 1, 1993, I was admitted to Taraz State University named after M.Kh. Dulati and graduated in 1998.

On January 3, 2002, under an individual employment contract, I was transferred to the position of Laboratory Assistant at the Department of Criminal Law Disciplines.

From February 18, 2003 to July 10, 2003, I worked as a Lecturer at the Multidisciplinary College of Taraz State University named after M.Kh. Dulati. On September 16, 2003, the employment contract was terminated by mutual agreement of the parties.

On September 22, 2003, I was employed at the “Taraz-Gasyr” College as a Lecturer in Law, and also performed the duties of Head of the Department. I resigned from this institution on August 27, 2008 at my own request.

On September 1, 2008, I was appointed Senior Lecturer at the Department of Criminal Law Disciplines of Taraz State University named after M.Kh. Dulati.

On September 1, 2016, following a competitive selection process, I was elected to the position of Senior Lecturer at the Department of Criminal Law and Criminal Procedure.

In accordance with Resolution No. 752 of the Government of the Republic of Kazakhstan dated October 11, 2019, and Order No. 346 of the Committee of State Property and Privatization of the Ministry of Finance of the Republic of Kazakhstan dated June 3, 2020, the Republican State Enterprise on the Right of Economic Management “Taraz State University named after M.Kh. Dulati” of the Ministry of Education and Science of the Republic of Kazakhstan and the Republican State Enterprise on the Right of Economic Management “Taraz State Pedagogical University” of the Ministry of Education and Science of the Republic of Kazakhstan were merged and reorganized into the Non-Profit Joint Stock Company “Taraz Regional University named after M.Kh. Dulati”.

On January 17, 2024, I was appointed Acting Head of the Department of Criminal Law and Procedure. Along with this position, I continue to work as a Senior Lecturer at the department.
